He's a night security guard, always friendly with the students, asking about their families. You note that all the students missing are single and without children. They have all disappeared on break or after class. In speaking to the security guard, you note that he tends to stay out of the direct light during your conversation.

While you're investigating the disappearances of the students, a staff member at the college approaches you. She and her co-workers have had a variety of bizarre experiences, but none of them have mentioned them to the administration because they are afraid of being ridiculed. The college administration offices are located in a converted house – the house of the original owners of the property. The land was sold to the college after the death of the patriarch of the family, and the sale involved some hard feelings. Coming in to work, the employees have smelled cigar smoke in their area. The smell has also been overwhelming in the middle of the afternoon on several occasions. The woman who approached you also confides that she has heard weird “bumping noises” in the supply room. When working alone in the evening about a week ago, she tells you, she went into the supply room to get something for her desk, and when she returned to the door, it was closed and locked from the outside. A good bit of banging and shouting resulted in a co-worker from another part of the building eventually unlocking the door. Her keys were still in the knob where she had left them.
